Warranty

This limited warranty applies only to Stealth HEHV27 Series (Model: SP-HE10227-H, SP-HE20427, SP-HE30727-H, SP-HE40927, SP- HE51227-H) system.

1. Definition

1.1 Suzhou Stealth Energy Technology Co., Ltd., is the guarantor of this limited warranty for products purchased or installed in: Australia

1.2 End User means the owner of the product or a company authorized by the owner to make a claim under this warranty

2. Warranty period

2.1 Product warranty

The warranty start date is the date the product was installed (based on the installer's invoice date), and Stealth offers a 10-year or 10,000-cycle warranty.

2.2 Performance guarantee

Stealth guarantees that from the start of the warranty period, the product will retain at least 80% of its usable capacity, or the minimum energy throughput rate, whichever comes first. The warranty only applies to the product in the instructions provided by Stealth and the product is in normal working condition.

The prerequisites for a valid performance bond are:

The operating ambient temperature of the product shall not be lower than 0°C or higher than 45°C $\,$

For batteries, the remaining available energy shall be measured and calculated according to the following test methods and test values:

The ambient temperature during the operation of the product is 25 $^\circ\!\mathrm{C}$ -28 $^\circ\!\mathrm{C}$

Discharge the battery with a constant current until the battery reaches the discharge cut-off voltage ('EODV') or reaches the self-protection voltage.

wait 10 minutes

Charge the battery to full capacity using constant current and constant voltage charging. wait 10 minutes

The battery is discharged with a constant current until the battery reaches the discharge cut-off voltage ('EODV') or reaches the self-protection voltage.

The calculation formula is: current capacity = discharge time * constant current value List of test values:

Stealth disclaims any statutory and implied warranties, including but not limited to any warranties of merchantability, fitness for a particular purpose or non infringement of applicable licenses.

The product distributor or any other person has no right to make warranty beyond the scope of this warranty or commitment beyond the warranty period on behalf of Stealth..

If the distributor or any other person makes a commitment beyond the scope of this warranty, the dealer or other person is responsible for it.

3.2 Limitation of Liability

In addition to this warranty, and only to the extent required by law, Stealth shall not be liable for any direct, indirect, special, accidental or derivative loss caused by the purchase or use of the product and its system, including but not limited to use loss, income loss, expected income loss, expected use loss, business loss, opportunity loss, goodwill loss, personal injury or damage loss, etc.

In any case, the liability caused by any reason shall not exceed the market value confirmed by stealth.

3.3 Warranty Limitations

The limited warranties described in clauses 2.1 and 2.2 do not apply to defects or malfunctions caused by:

a. The product has not been installed, maintained or operated in accordance with the instructions for use

- b. The product moves or vibrates after installation
- c. The product is exposed to temperatures above 50°C or below -10°C
- d. Using an incompatible inverter

e. Personnel without professional installation and maintenance qualifications modify or repair the product

- f. Significant damage to the product during transportation
- g. The product has not been used for more than 6 months.

3.4 Warranty Exclusions

a. Products purchased through unofficial channels (not from Stealth or Stealth authorized partners).

b. Material defects do not include wear and visual defects of the product (especially scratches, stains, mechanical wear, rust or mildew) provided that it does not impair the function and performance of the product.

c. Improper storage, improper transportation, improper handling, and improper delivery by distribution partners.

d. Overvoltage from DC side or AC side

e. Installed in an inappropriate location without following the installation manual, ambient humidity and temperature exceed limits.

f. The battery expansion was carried out incorrectly without following the installation manual.

g. The product serial number is not visible or has been changed

h. In the event of force majeure (such as natural disasters such as floods, fires, earthquakes, lightning strikes or other unusual environmental conditions, wars, etc.)

i. Beyond the specified warranty period

4. Replacement and maintenance

According to the following provisions, if the products or parts are defective in workmanship or materials, stealth will repair or replace them at its own option.

4.1 The product and the part to be replaced have the same performance and reliability as the original product, and if production is discontinued, withdrawn from the market, or no longer available in the region, Stealth may replace a product or part of equivalent value and performance (this Including used, same performance and reliability as new)

4.2 If Stealth fails to repair or replace the defective product or part, Stealth will compensate according to the following formula:

Amount = maximum claim amount * minimum usable capacity %

4.3 The above remedies are the sole and exclusive obligations of Stealth to the end user under this limited warranty. Stealth will not assume any responsibility for the end user's failure to meet the limited warranty terms.

6. Others

6.1 This warranty agreement is governed solely by Australian law, excluding choice of law rules.

6.2 End users may have statutory rights related to the sale of goods based on local laws. This limited warranty in no way limits any statutory or other rights the end user may have under the contract of sale.

6.3 If any term or part of a term of this Limited Warranty is held to be void, voidable or relatively void (whether against a particular party or in general), that term shall be void, voidable or relatively void void, the remainder of this clause shall remain in full force and effect.

6.4 As a condition of warranty claims, the End User agrees that, in the event of any dispute relating to technical facts, Stealth has the right to seek expert advice in accordance with the applicable international dispute resolution rules, provided that:
